## **MISSION STATEMENT**

## **TXSCYPAA BID REQUIREMENTS**

- 1. A Bid Committee must be represented by three A.A. members with a minimum of one year of sobriety and a roster of the committee members must be provided.
- 2. Bidders must provide a detailed report of their efforts to engage in AA's legacies of recovery, unity, and service.
- 3. Bidders must have a contract from at least one facility (hotels, universities, convention centers, etc.) that is able to accommodate the Conference's size and activities. However, we strongly suggest that you include at least two. Please include the proposed dates and diagrams of available meeting areas.
- 4. To ensure that TXSCYPAA operates in the spirit of cooperation, Bid Committees must present a list of large-scale A.A. events to be held in their city 30 days prior or 30 days after their proposed Conference dates.
- 5. Bidders must provide a tentative outline of the conference program.
- 6. Bidders must provide detailed financial records of all Bid Committee activities as well as a proposed budget for their Host Committee.
- 7. Bidders must create an available temporary Pre-Registration flier with a mailing address.
- 8. Bidders must read, understand, and be prepared to comply with the requirements as outlined in the Host Committee Responsibilities.
- 9. Bidders must provide a concise statement illustrating their reasons for bidding.



#### **BILLING PROCEDURES:**

Unless direct billing has been established, Customer will pay a 20% deposit of estimated costs at time of booking, a 50% deposit of estimated costs three months prior to arrival, with the remaining balance due two weeks prior to arrival. We offer direct billing to groups with an approved credit application by our accounting department based upon credit history. Any outstanding balance of the Master Account will be due and payable upon receipt of invoice. If payment is not received within 30 days, a Finance Charge of one and one-half percent per month (18% percent annual rate) or the maximum allowed by law, whichever is less, will be added to the unpaid balance commencing on the invoice date.

CANCELLATION: If cancellation of the entire group becomes necessary within 90 days of arrival, group is subject to cancellation fees equal to estimated total room and catering revenue. If cancellation becomes necessary between 91-180 days prior to arrival, group is subject to 75% of estimated total room revenue. If cancellation becomes necessary between 181 days and 270 days prior to arrival, group is subject to 50% of estimated total room revenue. If cancellation becomes necessary between 271 days and 365 days prior to arrival, group is subject to 25% of estimated total room revenue. If cancellation becomes necessary between 12 months and 24 months prior to arrival, group is subject to 10% cancellation fees equal to total room revenue. To avoid forfeiture of deposits paid or cancellation fees, the hotel must receive written notification at least 2 years prior to arrival date.







Up the Street Club was formed in 1997 by members of the Fresh Start Group of Alcoholics Anonymous. Over the last 21 years our club has grown to include several different 12 step fellowships and now hosts 70 meetings per week.

Young people are an integral part of our membership here at Up the Street Club. For the past several years we have hosted a weekly young people's meeting and younger people participate in several of the groups that meet here. Seeing so many young people celebrating on anniversary night is both uplifting and inspires one with the greatest confidence in the future of recovery in our area.

Our meetings are a destination for several treatment centers and sober houses. Many of these have a significant youth population. 





I think it would be cool to bring TXSCYPAA to the Gulf coast. I had almost three years sober before I even heard of YPAA, when a group of us went to ICYPAA 56 in San Antonio. I will be honest; my life and sobriety were changed after that conference. I think we had almost 20 people who went to that conference with us, of which 12 are still sober. Attending the conference really started the fire in our YPAA meeting and just set Clear Lake YPAA into motion. Last year when Houston hosted the conference, a few of the guys on the host committee came down to outreach for the conference and really started the YPAA push again. TXSCYPAA 37, once again, was sobriety and life changing. The Clear lake area has five treatment centers within 15 miles of each other, all of which support our meeting. That's roughly 150-200 people who are new in the program (most of them being young) who have never heard of YPAA, who don't know that you can and want to stay sober while having more fun that you ever did while you were out there. My hope is that they might have the same life changing experience with YPAA as I and countless other have had. All I really want to do is try to reach someone who is dying to stay sober and can't. To see young people get involved in YPAA, stay sober and be happy about it, and to see the same men and women who came in so lost and afraid of sobriety and dying of an illness, to see them fired up for this deal or be "Rocketed into the fourth

dimension" if you will, and to see them get involved with service work is the whole point behind YPAA and, hell, AA as a whole! "Our primary purpose is to stay sober and help other Alcoholics to achieve sobriety." So, I say all of that to say, there are hundreds of young members of Alcoholics Anonymous who would support our TXSCYPAA, have the opportunity to be involved in something bigger than themselves, and have the ability to find a spiritual experience due to this wonderful conference.
