Work in AA's Legacies

Three Legacies Report

We as a Bid Committee are first and foremost members of Alcoholics Anonymous and thus do our best as a collective to carry the three legacies of recovery, unity and service into our everyday lives. Naturally, this effort has carried over throughout the past year into our bid activities. Above all, we strive to carry the message to the newcomer as the hand of AA by showing them what YPAA - and AA as a whole – is truly about.

Recovery

Many of us on the bid sponsor others, showing that it is possible to have a joy-filled long term sobriety as a young person. Our own recovery has been enhanced by the work we do on this bid by staying honest and working with others. Some of us on the bid, took the responsibility of finding a new meeting space for the longest-standing Austin YPAA meeting, Tin Roof. Our members found a new location on short notice to keep the meeting alive without skipping a beat and continue to outreach for newcomers. Members on our bid have also continue to grow attendance of newcomers in another group called Young and the Restless, by adding a quarterly panel meeting. This alone has increased their attendance on a weekly basis and continues to bring others into recovery, even late on a Friday night.

Unity

This August, the Austin bid co-hosted a 2nd "Unity Day." We did so with not only the TXSCYPAA 37 Host Committee, but also our fellow bid cities and the TQCYPAA Host Committee. We understand that through it all, we share recovery together and that working with others is pivotal. With 95+ attendees at the event, we surpassed our numbers last year and were able to have a highly successful event with people from Austin, San Antonio, Kerrville, Houston, Fort Worth, and Dallas. We have made this event a staple in our bid, for the sole reason of bringing newcomers and alcoholics across the state together to celebrate recovery.

Service

Each of us not only hold a position on the bid, we also hold commitments at various levels throughout AA - from other conference committees, to outreaching, and to positions at our home groups. Members in our bid do H&I's and have outreached TXSCYPAA to those in treatment centers. Other members serve as GSRs. Further still, several members of our bid holding positions have either never before had a service commitment or have never worked on a conference. The level of dedication to service seen in our members on our bid, whether it be working on the bid itself or following through on one of our other service commitments, we strive to be of service in any way possible to the program of AA.

STATE COST-RECOVERY FEE

Texas Law imposes a margin tax on each company conducting business in Texas, including the Hotel Owner. CUTOFF DATE

Reservations by attendees must be received on or before 5:00pm, Friday, October 12, 2018 (the "Cutoff Date"). At the Cutoff Date, Hotel will review the reservation pickup for the Event, release the unreserved rooms for general sale, and determine whether it can accept reservations based on a space- and rate-available basis at the Texas Conference for Young People in Alcoholics Anonymous group rate after this date.

METHOD OF PAYMENT

The method of payment of the Master Account will be established upon approval of Texas Conference for Young People in Alcoholics Anonymous' credit. If credit is approved, the outstanding balance of Texas Conference for Young People in Alcoholics Anonymous Master Account (less any advance deposits and exclusive of disputed charges) will be due and payable upon receipt of invoice.

Texas Conference for Young People in Alcoholics Anonymous will raise any disputed charge(s) within 7 days after receipt of the invoice. The Hotel will work with Texas Conference for Young People in Alcoholics Anonymous in resolving any such disputed charges, the payment of which will be due upon receipt of invoice after resolution of the dispute. All meeting room, food and beverage, and related services are subject to applicable taxes (currently 8.25%) and service charge (currently 24%) in effect on the date(s) of the event.

FACILITY FEES-

Based on Texas Conference for Young People in Alcoholics Anonymous' requirements, Hotel's function space fees would be \$10,000.00. Based upon the Room Night Commitment and the functions identified on the Function Information Agenda/Event Agenda outlined in this Agreement, the Hotel will reduce these fees to \$5,000.00.

ROOMS ATTRITION

Hotel is relying upon Texas Conference for Young People in Alcoholics Anonymous' use of the Room Night Commitment.

Texas Conference for Young People in Alcoholics Anonymous agrees that a loss will be incurred by Hotel if Texas

Conference for Young People in Alcoholics Anonymous' actual usage is less than 80% of the Room Night Commitment.

If Texas Conference for Young People in Alcoholics Anonymous' actual usage is less than 80% of the Room Night Commitment, Texas Conference for Young People in Alcoholics Anonymous agrees to pay, as liquidated damages and not as a penalty, the difference between 80% of the Room Night Commitment and Texas Conference for Young People in Alcoholics Anonymous' actual usage, multiplied by the average group room rate, plus applicable taxes.

FOOD AND BEVERAGE ATTRITION/CANCELLATION

The Hotel is relying upon the food and beverage functions outlined below. Texas Conference for Young People in Alcoholics Anonymous agrees that a loss will be incurred by Hotel if there is a cancellation or reduction in the number of food and beverage functions and the number of food and beverage covers.

Texas Conference for Young People in Alcoholics Anonymous agrees that it will provide Hotel total Event food and beverage revenue of \$0.00, exclusive of taxes and service charges ("Agreed Event F&B Revenue"), subject to change(s) by Texas Conference for Young People in Alcoholics Anonymous no later than 72 hours prior to each function of the Event. Texas Conference for Young People in Alcoholics Anonymous shall provide Hotel with 72 hour advance notice of the date(s), time(s), and number of covers with respect to each function it wishes to schedule for the Event. Texas Conference for Young People in Alcoholics Anonymous shall provide Hotel this information no later than 72 hours prior to the scheduled time for each such function. The net number of covers resulting from this notice shall be referred to herein as a "Guaranteed Function".

If Texas Conference for Young People in Alcoholics Anonymous fails to (i) provide Hotel with the full Agreed Event F&B Revenue; or (ii) use all of the covers at any Guaranteed Function; or (iii) provide Hotel with any increase in the Agreed Event F&B listed in the Banquet Event Order, Texas Conference for Young People in Alcoholics Anonymous will pay Hotel within thirty (30) days, as liquidated damages and not as a penalty, the following amount:

- 1. The full per-guest price of any unused cover at any Guaranteed Function; plus
- 50% of the difference between the Agreed Event F&B Revenue and the actual Event food and beverage revenue received by Hotel (including any payment due under subparagraph (1), above); plus
- The Meeting Room Rental Fee (\$5,000.00).
- If applicable, state and local taxes will be added to all attrition and cancellation fees.

Hotel agrees that after receipt of this amount, it will not seek further damages resulting from the cancellation or attrition of such catered functions.

CANCELLATION

Texas Conference for Young People in Alcoholics Anonymous acknowledges that if it cancels or otherwise essentially abandons its planned use of the Room Night Commitment (a "Cancellation"), this action would constitute a breach of Texas Conference for Young People in Alcoholics Anonymous' obligation to Hotel and Hotel would be harmed. Because Hotel's harm (and Texas Conference for Young People in Alcoholics Anonymous' obligation to compensate Hotel for that harm) is likely to increase if there is a delay in notifying Hotel of any Cancellation, Texas Conference for Young People in Alcoholics Anonymous agrees to notify Hotel, in writing, within five (5) business days of any decision to Cancel. - (c) The amount set forth below reasonably estimates Hotel's harm for a Cancellation.

Texas Conference for Young People in Alcoholics Anonymous therefore agrees to pay Hotel, within thirty (30) days after any Cancellation, as liquidated damages and not as a penalty, \$9,760.00, plus applicable taxes, under this Agreement. Provided that Texas Conference for Young People in Alcoholics Anonymous timely notifies Hotel of the Cancellation and timely pays the above liquidated damages, Hotel agrees not to seek additional damages from Texas Conference for Young People in Alcoholics Anonymous relating to the Cancellation.

IMPOSSIBILITY

The performance of this Agreement is subject to termination without liability upon the occurrence of any circumstance beyond the control of either party – such as acts of God, war, government regulations, disaster, strikes (except those involving the employees or agents of the party seeking the protection of this clause), civil disorder, or curtailment of transportation facilities – to the extent that such circumstance makes it illegal or impossible to provide or use the Hotel facilities. The ability to terminate this Agreement without liability pursuant to this paragraph is conditioned upon delivery of written notice to the other party setting forth the basis for such termination as soon as reasonably practical – but in no event longer than ten (10) days – after learning of such basis.

COMPLIANCE WITH LAW

This Agreement is subject to all applicable federal, state, and local laws, including health and safety codes, alcoholic beverage control laws, disability laws, federal anti-terrorism laws and regulations, and the like. Hotel and Texas Conference for Young People in Alcoholics Anonymous agree to cooperate with each other to ensure compliance with such laws.

CHANGES, ADDITIONS, STIPULATIONS, OR LINING OUT

Any changes, additions, stipulations or deletions including corrective lining out by either Hotel or Texas Conference for Young People in Alcoholics Anonymous will not be considered agreed to or binding on the other unless such modifications have been initialed or otherwise approved in writing by the other.

LITIGATION EXPENSES

The parties agree that, in the event litigation relating to this Agreement is filed by either party, the non-prevailing party in such litigation will pay the prevailing party's costs resulting from the litigation, including reasonable attorneys' fees.

LIOUOR LICENSE

Texas Conference for Young People in Alcoholics Anonymous understands that Hotel's liquor license requires that beverages only be dispensed by Hotel employees or bartenders. Alcoholic beverage service may be denied to those guests who appear to be intoxicated or are under age.

AMERICANS WITH DISABILITIES ACT (ADA) COMPLIANCE

Each party agrees to use good faith efforts to ensure that it complies with its obligations under the Americans with Disabilities Act and the Act's accompanying regulation and guidelines (collectively the "ADA"). Each party further agrees to indemnify and hold the other party harmless from and against any and all claims and expenses, including attorney's fees and litigation expenses, that may be incurred by or asserted against the other party or its officers, directors, agents, and employees on the basis of the indemnifying party's non-compliance with any of the provisions of the ADA. Group agrees to provide Hotel with reasonable advance notice about the special needs of any attendees of which Group is aware.

COMPLIANCE WITH EQUAL OPPORTUNITY LAWS

This section does not apply to customers that are not part of the U.S. federal government. This section describes the Hotel's obligations as a federal contractor.

Hotel shall comply with all applicable laws, statutes, rules, ordinances, codes, orders, and regulations of all federal, state, local and other governmental and regulatory authorities and of all insurance bodies applicable to the Hotel premises in performing its obligations under this Agreement.

Hotel (referred to as "contractor" in this section) shall comply with Executive Order 11246, as amended, Section 503 of the Rehabilitation Act of 1973, as amended, and the Vietnam Era Veterans' Readjustment Assistance Act, as amended, which are administered by the United States Department of Labor ("DOL"), Office of Federal Contract Compliance Programs ("OFCCP"). The equal employment opportunity clauses of the implementing regulations, including but not limited to 41 C.F.R. §§ 60.1-4, 60-300.5(a), and 60-741.5(a), are hereby incorporated by reference, with all relevant rules, regulations and orders pertaining thereto. This contractor and subcontractor shall abide by the requirements of 41 C.F.R. §§ 60-1.4(a), 60-300.5(a) and 60-741.5(a). These regulations prohibit discrimination against qualified individuals based on their status as protected veterans or individuals with disabilities, and prohibit discrimination against all individuals based on their race, color, religion, sex, sexual orientation, gender identity or national origin. 




